Sector in identical post only), (6) Category/ sub category, (7) Permanent home address and (8) Postal address with phone/cell number etc.

The applications duly completed in all respect and supported by certified/ attested photo copies of relevant documents in support of their age, qualification, category, experience etc. as well as one passport size recent photograph duly attested (by any Gazetted officer) affixed thereon, should reach in this office within stipulated date and the applications found incomplete or received late will not be entertained and shall be rejected straightway without any intimation to the concerned candidate. **However, separate applications should be sent for each posts, if the applicants intend to apply for both posts.**
